3. COMPOSITION AND INFORMATION ON INGREDIENTS

Chemical Characterization: Mixtures

Description: Mixture of substances listed below with nonhazardous additions.

1317-65-3 Limestone (1) Skin Irrit. 2, H315; Eye Irrit. 2A, H319; STOT SE 3, H335 30%

Additional information: The weight percent for silica represents total quartz and not the respirable fraction.

4. FIRST AID MEASURES

Inhalation: Remove to fresh air. Seek medical attention if irritation persists.

Skin Contact:

In case of skin contact wash affected areas with water and soap. Hand lotion may be used to treat dry skin areas. If skin has become cracked, take appropriate action to prevent infection and promote healing. Seek medical attention if irritation persists.

When mixed with water, this material hardens and becomes very hot – sometimes quickly. DO NOT attempt to make a cast enclosing any part of the body using this material. Failure to follow these instructions can cause severe burns that may require surgical removal of affected tissue or amputation of limb.

Eye Contact:

In case of eye contact, rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Seek medical attention if irritation persists.

Ingestion:

Plaster of Paris hardens and, if ingested, may result in obstruction of the gut, especially the pyloric region. Drinking gelatin solutions or large volumes of water may delay setting. Seek immediate medical attention.

Water spray or some other extinguishing media appropriate for surrounding fire.

Specific Hazards Arising from the Chemical:

Not expected to burn. Above 1450° C - decomposes to calcium oxide (CaO) and sulfur dioxide (SO2). Above 800° C – limestone may decompose to calcium oxide (CaO) and carbon dioxide (CO2).

Special Protective Equipment and Precautions for Fire Fighters:

When fighting a major fire wear self-contained breathing apparatus and protective equipment.

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear appropriate personal protective equipment. Evacuate all non-essential personnel from affected area. Do not breathe dust. Ensure adequate ventilation.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Collect the spilled material and place into containers for salvage or disposal. If vacuum is used to collect dust, use an industrial vacuum cleaner with a high efficiency air filter. If sweeping is necessary, use dust suppressant. Do not use compressed air for clean up. Minimize dust generation. Ensure adequate ventilation. Avoid dust generation Ensure adequate ventilation.

7. HANDLING AND STORAGE

Precautions for Safe Handling:

Exposure to high dust levels may irritate the skin, eyes, nose, throat, or upper respiratory tract. Use wetsanding to reduce dust created. Prevent dust generation and accumulation.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry, ventilated area. Protect heat and moisture. As a dry powder, moisture will harden plaster of Paris during storage. Keep away from water and acids.

Engineering Controls:

Persons subjected to large amounts of this dust will be forced to leave area because of nuisance conditions such as coughing, sneezing and nasal irritation. Labored breathing may occur after excessive inhalation.

Skin: May cause skin irritation.

Eye: Dust can cause temporary mechanical irritation of eyes, burning, redness, itching and pain. **Ingestion:** None known.

Skin Corrosion / Irritation: Causes skin irritation.

Serious Eye Damage / Irritation: Causes serious eye irritation.

Respiratory or Skin Sensitisation: Based on classification principles, the classification criteria are not met.

Germ Cell Mutagenicity: Based on classification principles, the classification criteria are not met.

Carcinogenicity:

Silica dust, crystalline, in the form of quartz or cristobalite and formaldehyde are classified by IARC as a Group 1 - Carcinogenic to humans

Palygorskite (Attapulgite) (long fibres, > 5 micrometres) and acetaldehyde are classified by IARC as a Group 2B - Possibly carcinogenic to humans

Palygorskite (Attapulgite)(short fibres, < 5 micrometres) is calssified by IARC as Group 3 - Not classifiable as to its carcinogenicity to humans.

Ethenol, homopolymer is classified by IARC as a Group 3 - Not classifiable as to its carcinogenicity to humans.

Reproductive Toxicity: Based on classification principles, the classification criteria are not met.

Chronic Health Effects:

Plaster of Paris: Testing of dust from USG plaster of Paris has not detected respirable crystalline silica.

Crystalline Silica: Exposures to respirable crystalline silica are not expected during the normal use of this product; however, actual levels must be determined by workplace hygiene testing. The weight percent of respirable crystalline silica may not have been measured in this product. Prolonged and repeated exposure to airborne free respirable crystalline silica can result in lung disease (i.e., silicosis) and/or lung cancer. The development of silicosis may increase the risks of additional health effects. Smoking in combination with silica exposures increases the risk of cancer. The risk of developing silicosis is dependent upon the exposure intensity and duration.

Mica: Prolonged and repeated breathing of respirable mica dust may cause lung disease (pneumoconiosis). The extent and severity of lung injury correlates with the length of exposure and dust concentration.
